## Go Global Scholarships 2024

## **Terms and Conditions**

- **1.** You must be a current, undergraduate Newcastle University student who is paying UK Home tuition fees to be eligible for this scholarship.
- **2.** The scholarship is only available for students who are undertaking a short-term global placement, which has been approved by Global Opportunities.
- **3.** The scholarship may be used to support any expense associated with the global placement, including, but not restricted to placement/ tuition fees visa, travel and living costs while abroad.
- 4. Only students who meet one or more of the eligibility criteria (see below) are eligible to apply.
- **5.** Meeting the eligibility criteria and requirements does not guarantee that a scholarship will be awarded.
- **6.** The scholarship will be withdrawn if the approved placement is not eventually undertaken, in which case a member of Newcastle University Global Opportunities team must be informed at the earliest possible opportunity.
- **7.** Full participation in the placement is required and students must submit evidence of this (such as an official transcript or certificate provided by the host organisation). Should recipients not demonstrate completion of the placement, or provide insufficient evidence of completion, repayment of some, or all the scholarship may be required.
- **8.** The scholarship will be paid in full, on receipt of the required documents being provided to the GO Team (e.g. Certificate of acceptance, a placement offer or registration document from the host organisation). Payment will be made through the University payment system and payment transfers take a minimum of two weeks.
- **9.** Students undertaking a global placement with funding support from the GO Global Scholarship will be required to undertake all necessary administrative requirements.
- **10.** Students who receive a scholarship <u>will be required</u> to complete a feedback survey. This is a mandatory task.
- **11.** Additionally, scholarship recipients will be required to produce the following content:
  - a. A 'personal Profile' template
  - b. At least one photograph that positively represents their time abroad
  - c. To author a blog post a list of topics and guidance notes will be provided
- **12.** Failure to comply with the terms and conditions of the scholarship may result in recipients being required to pay back some or all of the funding provided.

**By submitting an application**, you understand and agree the information you provide will be shared with relevant Global Opportunities staff administering the funding. The content outlined in section 11 may be used for publicity and marketing purposes to help inspire the next cohort of students to undertake a global placement.

**Eligibility Criteria:** You must be a current, undergraduate Newcastle University student who is paying UK Home tuition fees to be eligible for this scholarship. You must also meet at least one of the criteria listed below:

- In receipt of the NCL Opportunity Scholarship / have an annual household income of under  $£40.000^{***}$
- In receipt of the Undergraduate Support Bursary
- Care leaver/ Care Experienced
- Carer/ Caring Responsibilities
- Estranged Student
- Refugee/ Asylum Seeker
- Gypsy/ Roma Travelling Community
- Black, Asian and Minority Ethnic group (BAME) & attended a UK state school throughout schooling

- \*\* **NB:** evidence should be from the parental household unless:
  - o The student is independent because they are over 25 years old
  - Are married, in a civil partnership or otherwise dependent on their partner for financial support (in which case, partner income counts towards the household income)
  - o Have children
  - o Are irreconcilably estranged from their parents
  - o Have supported themselves financially for 3 years before my course start date).

If evidence for only one parent is submitted, divorce certificate or a confirmation that the second parent is not employed is required.
