ERSC seminar 6: Genetics, Conflict, Race and Nation Building

The final seminar in our series will explore ways in which nation-building projects intersect with forensic technologies and security scenarios across boundaries. Using case studies, the seminar will explore how notions of nation are enacted or obscured by different social actors and their engagement with DNA technologies while constituting forensic databases, policing borders or fighting terrorism.

This seminar is part of a series of six interdisciplinary seminars (2015-2017), which critically examine contributions of forensic genetics to the production of security and justice in the UK and other contemporary societies. The series is influenced by the commitment of the ‘Europe 2020 Strategy’ to protect the security of social infrastructures and the safety and freedom of its citizens.

The series of meetings engages with the relevant biosocial research at the intersections of genetics, technology, security and justice. It brings together academic researchers, policy makers and practitioners from policing organisations, commercial forensic service providers, public sector organisations and civil society groups, in the UK and abroad. We discuss new research avenues towards informing UK policy and practice on the uses of genetic information to address the societal challenges of justice and security.
