

## Executive Education scholarships

Partial awards for 2024 entry

Newcastle University Business School is offering partial scholarship awards to outstanding and high-quality students to assist them to study for the Strategic Leadership MSc degree.

The awards will be credited to the student's fee account to reduce the overall cost of tuition fees.

This year, the Executive Education scholarships available are:

- **Diversity in Leadership Scholarship (Strategic Leadership MSc)**

### Terms and Conditions

1. To be considered for awards, applicants must be offered a place to study on the Strategic Leadership MSc programme at Newcastle University Business School for the 2024/25 academic year.
2. Applicants meeting most of the eligibility criteria will be considered during our interview process and priority will be given to applicants who most effectively satisfy eligibility criteria.
3. Awards may be exhausted early in the application cycle; early programme applications are therefore encouraged.
4. The value of the award available for students joining the Strategic Leadership MSc in September 2024 will be £12,000 across the two-year duration of the programme and will be credited to the student's tuition fee account based on £6,000 at the start of each academic year.
5. The Executive Education Scholarships are tuition fee discounts and have no cash value.
6. Successful applicants will be selected on the extent to which they meet the eligibility criteria, application, and performance at interview.
7. Once scholarship awards are issued, applicants must accept their scholarship offer within the time frame specified in their scholarship offer letter.
8. To receive awards, applicants must become registered students at Newcastle University Business School in the 2024/25 academic year for the Strategic Leadership MSc. Awards cannot be deferred to later academic years.
9. Scholarships are awarded on the basis that students commence and continue their studies for the academic years that the scholarship award is offered.
10. Scholarships are awarded on the assumption that students continue to fulfil the eligibility criteria and intention of the scholarships.
11. If a student's circumstances change during the programme, in that they no longer meet the eligibility criteria, we reserve the right to review and withdraw the scholarship offer.

12. If a student experiences personal or professional extenuating circumstances and requests to interrupt their studies, we reserve the right to review and withdraw the scholarship offer should this extend beyond one academic year.
13. Fully sponsored students do not qualify for these awards. A full sponsorship covers fees and maintenance. The University reserves the right to suspend payment and recover any scholarship amounts already made to students with full funding.
14. Newcastle University staff are not eligible to apply for Executive Education Scholarships.
15. Executive Education Scholarships will not be confirmed unless applicants can satisfy all conditions related to their scholarship offer, even if they are still accepted to study at Newcastle University.
16. Successful applicants cannot be in receipt of a Vice-Chancellor's International Scholarship award, Vice-Chancellor's Excellence Scholarship award, Vice-Chancellor's Global Scholarship Award, Newcastle University GREAT Scholarship, or an Elite Sports Scholarship. The list of schemes is not exhaustive, and applicants should check the regulations for all funding opportunities to which they apply to ensure eligibility.
17. Applicants may apply for and/or be considered for more than one scholarship or award offered by the University but can only receive one award. If successful in being offered more than one scholarship or award, the applicant will receive the highest value award with any lower value awards being reallocated to another applicant.
18. The International Family Discount and Alumni Discount may be held in conjunction with the Executive Education scholarships.
19. The Business School's decision on all Executive Education scholarship awards and interpretation of rules and regulations shall be final: appeals will not be considered.
