

MBA Developing Talent and Leadership Scholarship

Partial awards to contribute to tuition fees

Newcastle University Business School offers a number of partial MBA scholarship awards each year to assist high calibre MBA students with good qualifications to study for an MBA degree. The awards will be credited to the student's fee account.

Awards include:

Terms and Conditions

- An applicant can only be considered for a partial MBA scholarship after they have been offered a place to study on the full-time MBA programme at the University's Newcastle city centre campus for the 2024/25 academic year beginning in September 2024.
- 2. Eligible applicants will be considered automatically for awards at the point of MBA Interview. There will be up to 24 awards available for 2024/25 academic year. Awards may be exhausted early in the application cycle; early MBA programme applications are therefore encouraged.
- 3. The value of the awards will be between £5,000 and £13,000 and will be credited to the student's tuition fee account.
- 4. Successful applicants will be selected on merit based upon their application and interview performance. Allocation of scholarships will be based on the Business School's priorities which may alter from time to time.
- 5. To receive awards applicants must become registered students at Newcastle University in the 2024-25 academic year for the Full-time MBA programme. Awards cannot be deferred to later academic years.
- 6. Fully sponsored students do not qualify for these awards. This includes any students with alternative full fee scholarships or full sponsorship that covers tuition fees and maintenance costs. The University reserves the right to suspend payment and recover any scholarship amounts already made to students with full funding.
- 7. Scholarships will not be confirmed unless applicants satisfy all conditions related to their admissions offer.
- 8. Applicants may apply for and/or be considered for more than one scholarship or award offered by the University but can only receive one award. If successful in being offered more than one scholarship or award, the applicant will receive the highest value award with any lower value awards being reallocated to another applicant. It is the applicant's responsibility to check the regulations for all funding opportunities to which they apply to ensure eligibility. The University reserves the









- right to suspend payment and recover any scholarship amounts already made to ineligible applicants.
- 9. Applicants may be in receipt of the Alumni discount appropriate to them if they are eligible. Applicants may take advantage of the early fee discount of 2% alongside this scholarship.
- 10. These scholarships are for new students entering the full-time MBA programme in September 2024. Current students registered at the University who have already commenced their postgraduate degree are not eligible. Awards cannot be made retrospectively.
- 11. The Business School reserves the right to vary all or any scholarship awards at its sole discretion.
- 12. The Business School's decision on all MBA Scholarship awards and interpretation of rules and regulations shall be final: appeals will not be considered.
