The INCLUDE Vision

"Better healthcare through more inclusive research"

We define the underserved as 'those inadequately provided with opportunities to participate in research'

Phase I - Scoping

- Researched the underserved in clinical trials, professionals working on trials and those taking part in them
- Collated the barriers and challenges that contribute
- Identified innovations in trial design and delivery to enhance inclusion

Phase II – Developing a Framework (including roadmap and objectives with work streams)


- Produced the Framework: a roadmap suggesting intervention points to improve inclusion and core objectives and work streams
- Identified the importance of working with funders, regulators and other stakeholders to implement INCLUDE
- Working with stakeholders to decide routes to implementation and ways to evidence impact

Core Objectives


Develop Community Partnered Participatory Research building long-term relationships and opportunities for participation for underserved groups.

Work with funders, regulators and other stakeholders to remove barriers to including underserved groups in clinical trials.






INCLUDE Dissemination Framework
