Part of EDF's new strategy is to better integrate the different elements of our work (research, policy influencing and strategic communications) to maximise our impact. This call for information is part of this development and our commitment to evidence-based policy-making.

We are particularly interested in any work that explores:

- Public attitudes to human rights
- Empirical work on how human rights have been used in practice e.g. in education, housing, social care, to improve the decision-making or

practice of public bodies etc.

 Analysis of the constitutional, legal or practical implications of amending current human rights law and protections.
