#### 1.0: Background to the Newcastle NIHR Patient Safety Research Collaborative

#### 1.1: Context

Led by Professor Andrew Husband, the Newcastle NIHR Patient Safety Research Collaborative (PSRC) is focused on delivering visible research that results in real-world, transformative change for patient safety and health outcomes for those with multiple long-term conditions. Specifically, the work will be focused on the use of medicines, polypharmacy and the transfer of care between different healthcare environments.

There are four themes of focus making up the NIHR Newcastle PSRC:

- 1. Artificial intelligence and data science in multiple long-term conditions
- 2. Safer management of polypharmacy in multiple long-term conditions
- 3. Safer integrated health and social care environments
- 4. Safer management of multiple long-term conditions in disadvantaged communities

As reflected in our aims (discussed in Section 1.4 below), the NIHR Newcastle PSRC will ensure everyone can get involved with the research and work we do – including our staff, patients, and members of the public, regardless of protected characteristics, career stage or profession.

#### 1.2: Executive summary

Patient and public involvement, engagement and participation (PPIE) is central to our PSRC, which will ensure that research is co-produced with those most at risk of multiple long-term conditions (MLTCs). PPIE is embedded in all the themes, so that our PSRC addresses the needs of patients, carers and the wider community, thus enabling our research to be accessible and relevant, and leading to improved health and care. We have drawn upon engagement with patients/public to underpin the initial plans of our PSRC. We will build on existing, and create further, strong PPIE partnerships with local and regional public, community and patient groups.

We will embed PPIE in the development and delivery of our PSRC through its governance, influencing all stages of research activities and subsequent dissemination, thereby maximising impact. This PPIE strategy is a working document, which will be codeveloped with further input from PPIE members as the work of the PSRC progresses. Our PPIE approach and plans are informed by the UK Standards for Public Involvement in research. These are reflected in our **strategic objectives for PPIE for the PSRC, which are to**:

1. Co-produce and co-develop research in partnership with patients/public/communities.

- 2. Engage with communities and populations, under-represented in research and most affected by MLTCs.
- 3. Include public representation in the governance of our PSRC through visible involvement in leadership, research management, dissemination and knowledge mobilisation.
- 4. Equip, enable and empower researchers and patient/public members to build a vibrant, skilled and sustainable PPIE community.
- 5. Undertake continuous learning by assessing the difference that PPIE makes to research and share learning with research and practice communities in health and social care.

#### 1.4: Partnership approach to plans for PPIE in NIHR Newcastle PSRC

To achieve our aims and ensure our responsiveness, we will establish a patient/public advisory group (PPAG) group. Following consultation with other PPIE networks and members, we are taking a considered and deliberate approach to bringing this group together. We are starting initially with a small group of PPIE members who have had some contact with our PSRC, and thereafter, increasing the membership in a targeted way to reflect the diverse communities who are affected by the conditions our research will benefit. Given the strong emphasis of our PSRC on inequalities and engagement, we will have inclusive representation from the public and community groups, who are typically under-served by research, for example people excluded by ethnicity, socioeconomic status, deprivation, disability or geography. This group will be chaired by our PPIE co-lead, Olivia Grant. The process for establishing this group has started. The group will meet regularly, the timings and frequency of the meetings will be decided by the groups collectively, and will be guided by the needs of PSRC research. Feedback and input from the group will be reported back to the PSRC Management Group and in turn to the Scientific Advisory Group. This will support the further development of the PPIE strategy and plans, which will be revisited continually. This channel of reporting will ensure appropriate external public representation into the governance structures of our PSRC.

The PPAG group will inform the PSRC by providing input into our research, for example, by helping to prioritise research for Themes. They will be a constant source of advice and scrutiny on planning research activities, dissemination, recommendations and impact of research findings.

1.5: Programme of activities below describe our plans to engage with and reach out to marginalised populations

A key feature of our PPIE strategy is to provide training, development and support for PPIE both to researchers and to public/community groups, particularly those who are under-represented in research. The goal is to help both PPIE members and researchers build confidence, communication and practical skills in PPIE. By supporting community groups/voluntary sector to build capacity in engaging with research; we will build on our existing models of reciprocal partnerships with voluntary sector organisations, where training and development is provided to PPIE members. We will plan regular workshops and training events for PPIE members.

We plan to create innovative PPIE activities such as videos and blogs as part of our PPIE strategy for making research accessible, and for wider dissemination. To ensure inclusive and wider access, we plan on co-creating videos and providing infographics in different languages. We have budgeted these essential PPIE activities, which range from participating

in governance and management structures, planning research activities, training, developing accessible resources, and dissemination.

For building meaningful engagement with under-represented groups, we will undertake proactive outreach activities, with existing voluntary sector groups so that we take our research to communities and listen and learn from them. To implement this, we plan an 'embedded peer-researcher or PPIE' model, where members in the community/voluntary sector are supported to facilitate engagement and reach into communities, as well as to upskill PPIE researchers in voluntary sector. In collaboration with our regional voluntary, community sector and social enterprise (VCSE) support network (VONNE), the embedded peer-researcher will help reach out to and engage with community/voluntary groups (e.g., minority ethnic groups, deprived regions, rural communities), and provide input and insights on our research from the perspective those with the greatest needs. This role will enable upskilling and training members of community organisations or the voluntary sector. This approach will help create a reciprocal and sustainable model of PPIE. There is a successful pilot scheme of such a model in our region, which is supported by a collective of NIHR and other research networks. We have started discussions to join this collective effort to support a 'peer researcher' who will also link in with our PSRC.

Our strong collaborations at local, regional and national level provide keyleverage for our PPIE strategy. An important aspect of our approach to PPIE is to collaborate with and learn from other PPIE networks in our region, particularly with NIHR networks. We have taken time to listen to and build relationships with these different networks. 'Creating Connections' is a network in our region, which brings together PPIE across NIHR North East North Cumbria Applied Research Collaboration (NENC ARC), Fuse Centre for Translational Public Health Research (NIHR School for Public Health Research), and the NIHR Biomedical Research Centre (BRC), and VOICE. VOICE (<a href="https://www.voice-global.org/">https://www.voice-global.org/</a>) is a global PPIE platform hosted at the National Innovation Centre for Ageing at Newcastle. The regional 'Creating Connections' Group co- ordinated by the NIHR Research Support Service (RSS) bring together public involvement networks across NIHR infrastructure, NHS organisations and Universities. We will also seek to extend our links with other relevant networks, such as the Cumbria, Northumberland, Tyne and Wear NHS Foundation Trust (CNTW) PPIE group. We will work with these collaborations to share ideas and learning, plan our dissemination, training, and knowledge mobilisation activities.

#### 1.6: Learning and evaluation

Learning from undertaking PPIE in research is fundamental to our PPIE plans. Our PSRC research will be evaluated to assess the impact that PPIE is having on research, wider PPIE community, and on the impact our research is having on people affected by multiple long-term conditions (MLTCs). Building capacity and skills amongst PPIE contributors, including enhancing professional and personal skills, confidence and self-esteem are important outcomes our PPIE strategy seeks to achieve. Similarly, up-skilling our researchers to have the confidence and skills to undertake meaningful PPIE are impacts we will look to evaluate. We will also understand and seek input from our PPIE members about what they find to be important to measure the impactof PPIE.
