- The Clinical Science Medical Physics suite of programmes accepts applications for:
  - a) Credit transfer
  - b) Recognition of prior certificated learning
  - c) Recognition of prior experiential learning
- In ALL its programmes:
  - MSc in Clinical Science (Radiotherapy Physics) 5249P
  - MSc in Clinical Science (Radiation Safety and Diagnostic Radiology) 5250P
  - MSc in Clinical Science (Nuclear Medicine) 5251P
  - MSc in Clinical Science (Imaging with Non-Ionising Radiation) 5252P
- For all modules except the following:
  - MSC8006 & MSC8007 Professional Foundations of Healthcare and Clinical Science (20 credits):** Excluded from RPL/Credit transfer as this module provides trainees with a broad knowledge and understanding of patient care, patient safety, service delivery, research and innovation contextualised to professional practice within healthcare science.
  - MSC8003 Research Project 1 Identifying and Planning a Project (30 credits):** Excluded from RPL/Credit transfer as this module is required to develop the research proposal for the research project.
  - MSC8004 Research Project 2 (30 credits):** Excluded from RPL/Credit transfer as it is the dissertation project for all programmes.

The maximum credit for which RPL/Credit transfer can be offered is 40 credits for a Masters programme.

Normally only learning within the last 5 years can be taken into account.

### **Evidence required:**

For a) and b) above – transcript showing level, credits and marks plus copies of syllabuses.

For (c) – dates and details of relevant experience with evidence (e.g. employer statement) and an explanation as to how the learning outcomes of the modules for which the applicant seeks RPL have been met.

MPY8001: RPL for this module will also require a written examination to be passed.

## WHAT ADVICE AND INFORMATION WILL BE GIVEN

Each applicant for RPL or credit transfer will be issued with the relevant module outline forms specifying learning outcomes and given an RPL/Credit transfer application form.
