- 1. The above programmes accept applications for:
 - Credit transfer
 - Recognition of prior certificated learning (RPL)

Due to the nature of the programme applications for Recognition of Prior Learning based on recognition of prior experiential learning are not accepted.

Normally only learning within 5 years will be considered, except in exceptional circumstances at the discretion of the Degree Programme Director.

2. Applicants who are accepted onto the Postgraduate Certificate, Postgraduate Diploma or Masters in medical education may be eligible to apply for RPL for 20 credits for the following module:

Teaching and Learning in the Classroom: (MEE8071/MEE8500)

3. Alternatively:

- Applicants who are accepted on to the Postgraduate Diploma or Accelerated
 Masters, and who have successfully completed a similar Postgraduate Certificate level degree programme elsewhere, or the Postgraduate Certificate in Clinical or
 Medical Education at Newcastle University, may be eligible for RPL/credit transfer
 to the value of 60 credits (the equivalence of the Postgraduate Certificate stage of
 the programme), subject to approval by the Degree Programme Director.
- Applicants who are accepted on to the Part-Time Master's, and have successfully completed either: -
 - The Postgraduate Certificate and Postgraduate Diploma in Clinical or Medical Education at Newcastle University OR
 - The Accelerated Postgraduate Diploma in Clinical or Medical Education at Newcastle University.

may be eligible for credit transfer to the value of 120 credits (the equivalence of the Postgraduate Certificate and Postgraduate Diploma stages of the programme).

Whether you are exempted from the one module or from a full 60 credits will be based upon the evidence that you present and is at the discretion of the Degree Programme Director (for 20 credits or 60 credits) or the Postgraduate Dean (for 120 credits).

4. Other Arrangements

The Programme has a specific arrangement with The Postgraduate School of Primary Care that GPs who have successfully completed the Intending Trainers Course with that institution will be automatically given RPL for the Teaching and Learning in the Classroom module. GP trainers who have completed a similar course elsewhere would be eligible for the same.
