This statement covers the following Postgraduate Psychology programmes:

Postgraduate Certificate in Cognitive Behavioural Therapy Studies  
Postgraduate Certificate in Low Intensity Psychological Therapies  
Postgraduate Diploma in Cognitive Behavioural Therapy (Full and Part-time Routes)  
MSc Foundations in Clinical Psychology  
MSc in Forensic Psychology  
MSc in Forensic Psychology (non-accredited)  
MSc Sport & Exercise Psychology  
Doctorate in Clinical Psychology

**Note: Restrictions apply to postgraduate programmes, including those under the NHS Talking Therapies initiative.**

- The Postgraduate Certificate in Cognitive Behavioural Therapy Studies is a Continuing Professional Development (CPD) professional programme and so applications for RPL/RPEL or Credit Transfer are not accepted.
- The Postgraduate Certificate in Low Intensity Psychological Therapies is a professionally approved and accredited programme. Due to accreditation and National IAPT requirements the programme does not accept applications for RPL/RPEL or Credit Transfer.
- The Postgraduate Diploma in Cognitive Behavioural Therapy-Full and part-time routes (which incorporates the IAPT curriculum for High Intensity Psychological Therapies) will accept RPL and Credit Transfer for the following modules to a maximum of 60 credits: PSY8090, PSY8091, PSY8092, PSY8093, PSY8094, PSY8095, PSY8096. These credits must come from comparable modules within programmes accredited by the British Association of Behavioural and Cognitive Psychotherapies (BABCP) or their equivalent. Recognition of Prior Experiential Learning is not

accepted. For accreditation reasons applications for RPL/RPEL or credit transfer are not accepted for the CBT Practice Modules, PSY8097, PSY8098 and PSY8099.

**Note:** Exit Postgraduate Certificates in Cognitive Behavioural Studies awarded by this Institution may not be used for RPL or credit transfer against a higher qualification in any other Newcastle University School of Psychology programme unless specified.

- The MSc Foundations in Clinical Psychology will accept up to 40 credits of Credit Transfer/RPL if the content of such credits comes from similar modules taken at level seven elsewhere. Recognition of Prior Experiential Learning is not accepted.
- The MSc in Forensic Psychology is a professionally approved and accredited programme. Due to accreditation requirements the programme does not usually accept applications for RPL/RPEL or Credit Transfer. However, we will accept up to 20 credits of credit transfer if a student has previously completed the Newcastle University module PSY8046 (Legal Psychology and the Criminal Justice System, 20-credit module), or PSY8061 (Advanced Research Methods for Applied Psychology A, 10-credit module).
- The MSc in Forensic Psychology (non-accredited) is a professionally approved programme. Due to approval requirements the programme does not usually accept applications for RPL/RPEL or Credit Transfer. However, we will accept up to 20 credits of credit transfer if a student has previously completed the Newcastle University module PSY8046 (Legal Psychology and the Criminal Justice System, or PSY8061 (Advanced Research Methods for Applied Psychology A, 10-credit module).
- The MSc in Sport and Exercise Psychology is a professionally approved and accredited programme. Applications for RPL/credit transfer will be assessed on a case-by-case basis and we will accept up to 20 credits of RPL/credit transfer, these credits must come from an equivalent Level 7 module with comparable content and learning outcomes. Recognition of Prior Experiential Learning (RPEL) is not accepted.
- The Doctorate in Clinical Psychology is a professionally approved and accredited programme. Due to the nature of the programme and accreditation requirements the programme does not accept applications for RPL/RPEL or Credit Transfer.

For those programmes that do accept Credit Transfer and RPL normally only learning within the last five years can be taken into account.

### What evidence will be required:

Applicants will be asked to supply a transcript showing level, credits and marks plus copies of syllabuses.

## WHAT ADVICE AND INFORMATION WILL BE GIVEN

Each applicant for RPL or credit transfer will be issued with the relevant module outline forms specifying the learning outcomes and given an RPL/credit transfer application form.

Applicants will be advised to send details and evidence of the relevant certificated learning.

Applicants will also be advised that they may also be invited for interview to discuss further details of their prior learning.

## HOW RPL DECISIONS ARE MADE

Applications should be submitted via e-mail to the DPD for consideration.

Decisions of the application of RPL will be made by the DPD in consultation with other selectors for each programme.

Applicants should hear the results of their application within 20 working days.
